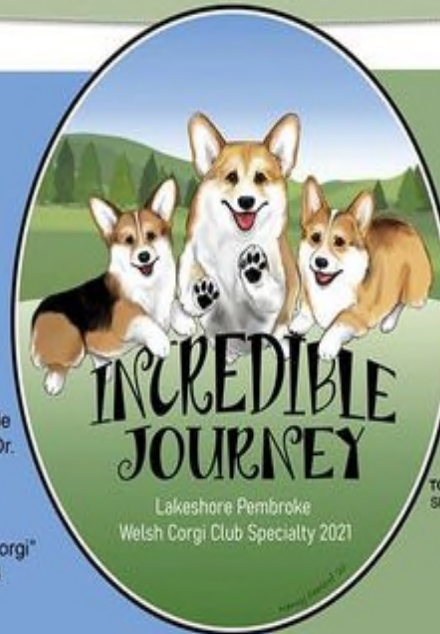

#### Veterans Classes

Classes for dogs & bitches 7 years & under 10 years, 10 years and over.  
Sexes divided.

Winners of the Veteran Classes may compete in Best of Breed Competition if otherwise undefeated the day of the show. The AKC allows spayed bitches and castrated dogs to be shown in the Veterans Class at Independent Specialty Shows, and are eligible for competition in Best of Breed. *Chapter 11, Section 8 of the Dog Show Rules.*

#### BEST PUPPY COMPETITION

Best Puppy competition is open to all first place winners of the 6-9 month and 9-12 month Regular Puppy Classes. As this class is judged after the Best of Breed is named, it is considered a separate, new competition and any previous defeats in the Winners class do not prohibit a puppy from competition in this class. If a puppy wins Best of Breed or Best of Winners, that puppy will automatically win Best Puppy.

**Novice Class:** This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

**Open Class:** This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Open class will be divided: Junior, Intermediate, Senior.

**Master Class:** This class will be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won the 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and Must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

**Junior Handlers must include their AKC Junior Handler Number on each entry.**

You may obtain your junior identification number by calling the AKC at 919-233-9767.  
Be sure all information for Junior classes is entered on the front and back of the entry form.

## 4-6 Month Beginner Puppy Competition

Thursday & Friday, November 4 & 5, 2021

One combined class, not divided by sex, will be offered for Pembroke Welsh Corgi that are at least four months and under six months of age on the day of the competition. All of the puppies are exhibited in the same class and the only placements are Best of Breed (BOB) and Best of Opposite Sex to Best of Breed (BOS).

Entry and eligibility requirements:

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the *Rules Applying to Dog Shows*. A foreign born dog may enter this class if they are registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers are not permitted to exhibit in this class. (Professional handlers are defined as anyone who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.)

Once the limit has been reached in any class, subsequent UDX or RAE/RACH entries will be returned in their entirety.

### Bitch in Season Refund Policy

The Club will refund 50% of the entry fee for bitches unable to compete for that reason. All refund requests must be accompanied by a dated, signed letter on official business letterhead from your veterinarian stating the reason that your dog cannot compete. E-mails, phone calls and non-letterhead notes will not be considered. All requests must be received by the Show Secretary one half hour prior to the start of judging on the trial date.

**Obedience and Rally transfers** will be permitted in accordance with Obedience Regulations, Chapter 1, Section 16 and Rally Regulations, Chapter 1, Section 15. The request to transfer must be presented in writing to the Show Secretary at least 30 minutes prior to the start of each trial.

All Obedience and Rally classes will be run in jump-height order from Small-Tall.

All Obedience or Rally entries must indicate class "A" or "B" and/or jump height where required.

Obedience and Rally ring size will be 40 x 50.

Each Obedience and Rally trial is a separate event number. When entering, please pay the fee for the first entry of the dog in EACH trial, as they are separate events. The second fee is used when entering multiple classes in the same event number (i.e. UDX/RAE/RACH).

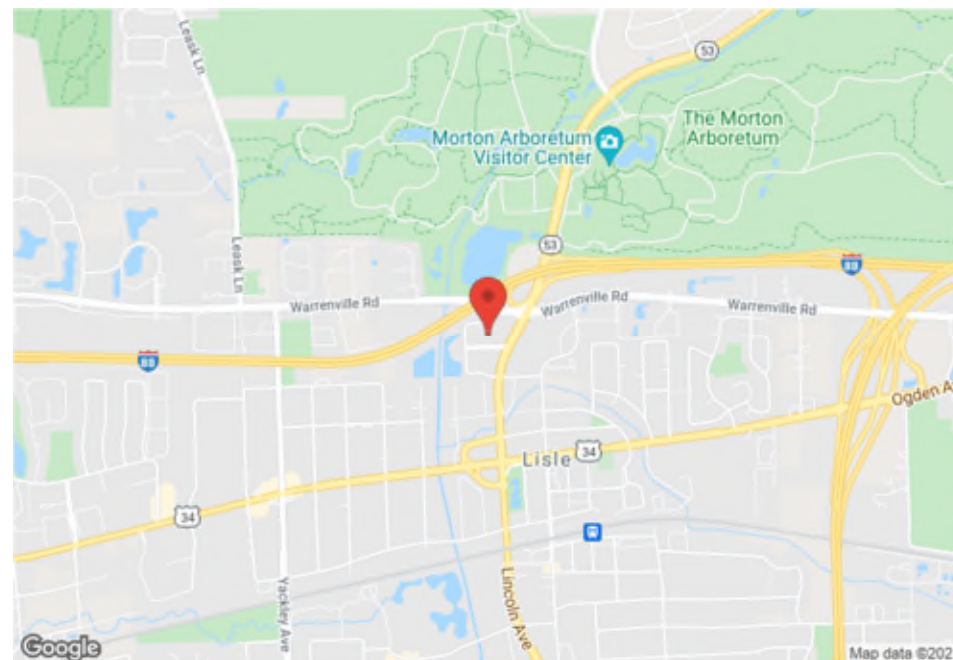
